### A RESOLUTION RECOGNIZING AND COMMENDING BELLA DELLIPOALA FOR HER BRAVERY AND WILLINGNESS TO ACT CALMLY AND QUICKLY WHILE ASSISTING AND HELPING AN AMHERST SENIOR CITIZEN IN THE CITY OF AMHERST AND HEREBY DECLARING AN EMERGENCY.

WHEREAS, BELLA DELLIPOALA has exemplified civic spirit, outstanding conduct, fastacting, and life-saving action while noticing an Amherst elderly citizen in dire need of assistance on January 21, 2022 and

WHEREAS, BELLA DELLIPOALA, with distinction and dedication utilized the skills she learned in the Amherst City Schools Medical Tech Program to quickly come to the aid and rescue of an Amherst elderly citizen who was injured and incapacitated after falling outside of her residence in freezing cold temperatures, and

WHEREAS, BELLA DELLIPOALA played a major role in the rescue and notification of emergency services to save an Amherst elderly citizen and continued to remain by her side and keep her warm and calm until police, firefighters, and paramedics arrived; and

NOW THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF AMHERST STATE OF OHIO:

SECTION I. That Amherst City Council does hereby recognize and commend Amherst citizen and student BELLA DELLIPOALA for acting so quickly, calmly, and utilizing the skills she learned, and wishing her much success and prosperity as she continues toward achieving her personal and academic goals.

SECTION II. That a duly certified copy of this Resolution be presented to BELLA DELLIPOLALA to symbolize the City's gratitude to BELLA DELLIPOLA as well as a tribute to her spirit of bravery, helpfulness, empathy, dedication and service to this member of our elderly community.

SECTION III. That it is found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were adopted in an open meeting of this Council and that all deliberations of this Council and of any of its committees that resulted in such formal actions were in meetings open to the public, in compliance with all legal requirements including Section 121.22 ORC.

SECTION IV. That this Resolution is hereby declared an emergency measure necessary for the preservation of the public peace, health, safety and welfare of the citizens of Amherst, Ohio, the emergency being the need to provide immediate recognition to the City's inhabitants and provided it receives the majority of vote of two-thirds or more of those elected to City Council, it shall go into full force and effect from and immediately after its passage and its approval by the Mayor; otherwise it shall take effect at the earliest date provided by law.
