Dear Mayor Costilow:

Please accept the following Proposal for Final Professional Engineering and Surveying Services pertaining to the above referenced project.

#### **Project Description**

This safety improvement project will provide improvements to several sections of North Main Street as well as the intersection with Cooper Foster Park Road. These heavily traveled roadways are main thoroughfares within the City of Amherst. Improvements include resurfacing of a portion of N. Main St., reconstruction of a portion of N. Main St. to relocate roadway away from an eroding hillside and widening of N. Main St. on the approach to the Cooper Foster Park Road intersection for additional turn lane storage length. Cooper Foster Park Rd. will also be widened to realign westbound traffic through the intersection. Lastly, storm and drainage improvements will be performed to maintain drainage along reconstructed areas.

Turn lane improvements will be provided as recommended in the Traffic Engineering Study performed by TMS Engineers. The recommended turn lane improvements have been included with this project. This project will greatly improve road rideability and safety for the traveling public. Reflective signage upgrades will provide additional safety throughout the corridor.

The Project has been submitted to the Lorain County Engineer's Office for OPWC Issue I, Round 33, funding for 2019. The project was placed on the funded list for OPWC with funds becoming available in July of 2019. The project has been divided into two parts since the OPWC funding is not available until July of 2018.

Design and Construction Services Proposal

#### Scope of Services

To meet your objectives the project Scope of Services to be provided by Bramhall Engineering & Surveying Company (BESC) shall include the following:

### Task I - Plan Preparation and Bidding Administration

- Perform topographic survey of the project area.
- Coordinate with the Amherst Utility Department on relocation of any sanitary, water, storm and electric infrastructure.
- Contact OUPS and work with Private Utility Companies on to resolve any utility conflicts.
- Assist the City of Amherst in scheduling and coordinating meetings with affected residents within the project area.
- Coordinate with the project Geotechnical Sub-consultant who will perform bores and cores of existing soil and pavement to be rehabilitated. Cores will be utilized to determine existing pavement and sub-base buildup and will provide for a basis to determine the details of the proposed pavement rehabilitation.
- Coordinate with the project Traffic Engineer Sub-consultant who will development Traffic Signalization Plans for the Intersection.
- Prepare construction plans and specifications.
- Prepare stormwater management calculations and report.
- Prepare bid documents and administer the bidding process including preparing a bid form, engineers estimate, attend prebid meeting, issue addendums as required in response to contractor questions, tabulation of bids, bid review, and bid recommendation.

#### Task II - Construction Administration and Inspection

- Provide full time project representative to provide onsite inspection.
- Verify contractor conformance to project specifications and City requirements.
- Verify material quantities.
- Conduct a preconstruction meeting, and regular routine project meetings.
- Review of Construction Pay Requests for accuracy and completeness, determination of contract quantities and resolution of onsite issues.
- Provide initial construction staking & layout as required to facilitate construction.
- Provide Inspector Markup as-builts of the constructed improvements.

#### Construction and Engineering Budgets are as follows:
